TERMS & CONDITIONS:

1. His appointment will be purely on contract basis for 03 years (extendable), he will be initially on probation for a period of six (06) months (extendible up to 12 months).
2. His services can be terminated at any time without assigning any reason.

4. He will produce a Police clearance certificate from the quarter concerned.
5. He will produce a certificate of Medical Fitness from the concerned Medical Superintendent/Civil Surgeon before joining his duty.



6. He will produce original documents which will be verified from the concerned authorities. The Provided documents if found non-verified, KP-TEVTA will have the right to terminate the appointment and expenses incurred on appointment will be charged to the candidate upon misleading the organization.
7. He will have to perform duty at any station assigned to him in connection to his job and other affairs of this authority.
8. He will have to join duty at his own expenses.
9. In case he wishes to resign at any time, one month prior notice will be necessary or in lieu thereof one month salary shall be forfeited.

Note: He/she should report to Head Office HR Dept on 29th January, 2019 at 10:00 AM for submission of declaration of his consent about acceptance/refusal and date of reporting for duty at institute, as the case may be on prescribed Performa. In case of non compliance, the offer of appointment will lead to the next in waiting or treated as cancelled.
