 - Earnest money to the extent of 2% in the shape of call deposit in favor of “**Managing Director KP-TEVTA**” must be accompanied with the bidding documents.
 - CNIC Copy of the bidder.
 - Copy of Registration and renewal of “PEC” of the CFY (2019-20).
 - Copy of Registration with KPRA and FBR.
- Bidder found with bogus documents, their tenders will be rejected and their cases will also be forwarded to the higher ups for black listing.
- In case the Contractor quoting below rates more than 10% on Engineer cost estimate the contractor will have to deposit additional security in the form of call deposit equal to 8% of the engineering estimated cost. Otherwise the tender will be considered as non-responsive.
- Any Cutting/ overwriting or Incomplete BOQ will liable for rejection for the tender and bid may be declared defective.
- Incomplete / or unsigned BOQ/Tender Documents will be considered as defective /non responsive.
- Sealed bids sent through registered mail courier or by hand should reach to the office of the Director (Works), KP-TEVTA Head Office on the above cited date Up-to **10:30AM** and will be opened on the same day at **11:00AM** in Presence of bidders who choose to attend the opening. The delay in delivery of the tender document will be the responsibility of the bidder.
- All applicable taxes including (Federal and Provincial Taxes) etc. shall be deducted from the bill of the contractor/firms at prescribe rates Notified by the Govt. from time to time.
- The firm/Contractor should be register with Sales Tax/Income tax/KP-Revenue authority and regular tax payer. The bids should be supported with certificates/testimonials.
