

#### **TERMS & CONDITIONS**

- 1) bids are invited from reputed Manufacturers/suppliers/Firms under <u>Single Stage</u>, <u>Single Envelop</u> procedure on FOR basis and bids completed in all respect should reach to the Office of <u>Principal</u>, <u>GCT Peshawar</u> through registered mail or Courier Services on or before above mentioned date and time. The bids will be opened on the same day by the Procurement committee in the presence of bidders/Representatives who want to attend. Bid received after 12:00Noon on 31/12/2020 shall not be entertained.
- 2) The Items/Equipment must have Minimum Specification acceptable to the Technical/Purchase Committee of GCT Peshawar; however the higher specification may be accepted if within the financial limit.
- 3) Bidder can bid for items as per Schedule of requirement published on KPTEVTA Website and having specialty /experience.
- 4) Sale tax, Income Tax and any other taxes / Duties Levied against the item shall be deducted at prescribed rate as per Government Policy.
- 5) All bidders must submit the relevant details of Technical & Financial proposals and also to provide documents in soft copies on CD/USB drive, duly labelled by a permanent marker with the name of bidder/supplier.
- 6) The Firm/suppliers must be registered with the KPPRA, Sales Tax and Income Tax Department (Registered on active Tax Payer list of FBR and NTN and GST Number). Photocopy of Valid registration shall be attached with the bid documents
- 7) The Supplier shall write in bold & legible letters "Name of the Project" on the envelope, otherwise tender will not be entertained.
- 8) Detailed terms & conditions and bids documents can be obtained from office of the undersigned on any working day **or can be downloaded from the KP-TEVTA, official website www.kptevta.gov.pk.** and the Bid Processing fee @ Rs. 1000/- (Non-Refundable) payable in cash during working hours. Otherwise bid will be considered non-responsive
- 9) Bidders shall enclose 2% as Bid Security in the envelope, of the bid through Call Deposit Receipt (CDR) otherwise bid will not be considered. It will be released after successful submission of 10% Performance Guaranty CDR or Bank Guarantee on a Local stamp paper. Performance Guarantee will be released after successful Completion of warranty period.
- 10) The rates shall be on FOR basis and store must be delivered to the specified consignee's end as mentioned in Purchase Order (PO) while PO is the integral part of procurement. In case of failure of supply, the performance Guarantee shall be forfeited in favour of Principal GCT.
- 11) Store shall be supplied within 20 days after issuance of supply order and time period mentioned in supply order/work order will not be extendable at any cost.
- 12) Before supply of bulk store items, sample of each item of supply order/work order must be supplied to this college for approval from the purchase committee/ expert committee for checking as per tender specification.
- 13) Bid validity period will be applicable for fiscal year 2020-21.
- 14) The supplier will submit the tender documents along with terms and conditions duly signed by the authorized personnel with company seal otherwise the bid will not be accepted.
- 15) The bidder will be responsible for standard local warranty given by the manufacturer where applicable.
- 16) The Competent Authority reserves the right to increase or decrease the quantity of items as per availability of budget as well as on the recommendation of the procurement committee.
- 17) The Competent Authority reserves the right to reject any or all the bids as per KPPRA rules with cogent reason.
- 18) Any other condition included in KPPRA rules 2014, besides the above shall also be applied on the bidders.
