#### **TERMS & CONDITIONS**

- 1) Technical and Financial bids are invited from reputed suppliers under <u>Single Stage</u>, <u>Two Envelopes</u> procedure and bids completed in all respect should reach to the Office of <u>Principal</u>, <u>Government Polytechnic Institute</u>, <u>Sajawal Sharif Mansehra</u> through registered mail or Courier Services on or before above mentioned dates and time. The Technical bids will be opened on the same day by the Procurement committee in the presence of bidders/Representatives who want to attend. Bid submitted after due date & time shall not be entertained. Financial Bids will be opened after Technical and Firm Evaluation.
- 2) The Items/Equipment must have Minimum Specification acceptable to the Technical Committee of Institute; however the higher specification may be accepted if within the financial limit.
- Bidder can bid for items as per Schedule of requirement published on KPTEVTA/Institute Website and having specialty /experience as described in BSD.
- 4) Sale tax, Income Tax and any other taxes / Duties Levied against the item shall be deducted at prescribed rate as per Government Policy.
- 5) All bidders must submit the relevant details of technical & financial proposals in separate Envelopes and also to provide documents in soft copies on USB DRIVE, duly labelled by a permanent marker with the name of bidder/supplier.
- 6) The firm may not be blacklisted/debarred temporarily or permanently by any Government/Autonomous/Semi-Autonomous/authority. If at any stage of the procurement process a firm is found blacklisted/debarred temporarily or permanently and information is not shared by the firm/bidder with KP-TEVTA and Institute then, KP-TEVTA and Institute shall have the right to forfeit 2% bid security or 10% Performance Guarantee in favor of GPI Mansehra. The statement of non-blacklisting shall be submitted along the Technical bids through an affidavit on official stamp paper of worth Rs.100/- of Government of Pakistan.
- 7) The supplier must be registered with the Sales Tax and Income Tax Department & Khyber Pakhtunkhwa Revenue Authority. Photocopy of valid registration shall be attached with the bid documents.
- 8) The Supplier shall write in bold & legible letters "Name of the Project" on the envelopes otherwise tender will not be entertained.

Otherwise bid will be considered non-responsive.
- 11) Two (2%) Percent bid security of the bid cost in shape of Call Deposit Receipt (CDR) in favour of Principal GPI Mansehra must be sealed in financial proposal. However, the technical Proposal shall have affidavit stating that 2% bid security is enclosed in the financial proposal without stating the figures. Otherwise bid will be considered non-responsive. Pay Orders will not be accepted.
- 12) The rates shall be on FOR basis and format of BSD form 06 (price schedule) shall be strictly followed; otherwise financial bid will be non-responsive considered.
- 13) The successful Bidder will deposit 10% as performance Guarantee against the purchase order (through Call Deposit Receipt (CDR) before the award of contract. It will be released after successful supply or Completion of warranty period.
- 14) Bid validity period will be applicable for fiscal year 2021-22.
- 15) The supplier will submit the tender documents properly <a href="Computer Typed/Page Numbered">Computer Typed/Page Numbered</a> along with terms and condition issued by the Institute/KP-TEVTA dully signed by the authorized personnel with company seal. Soft Copy of Technical Bid with complete technical specifications of the quoted items shall be provided in a USB Drive; otherwise the bid will not be accepted.
