The Khyber Pakhtunkhwa Technical Education & Vocational Training Authority (KP-TEVTA) invites sealed bids under National Competitive bidding from manufacturers/suppliers for the purchase of Training Equipment under the following projects.

TERMS & CONDITIONS

- 1) Technical and Financial bids are invited from reputed Manufacturers/suppliers under **Single Stage, Two Envelopes** procedure and bids completed in all respect should reach to the Office of Director Procurement, Khyber Pakhtunkhwa Technical Education and Vocational Training Authority through registered mail or Courier Services on or before above mentioned dates and time. The Technical bids will be opened on the same day by the Procurement committee in the presence of bidders/Representatives who want to attend. Bid submitted after due date & time shall not be entertained. Financial Bids will be opened after Technical and Firm Evaluation.
- 2) The package must have Minimum Specification acceptable to the Technical Committee of KP-TEVTA; however, the higher specification may be accepted if within the financial limit.
- 3) Bidder can bid for complete package as per Schedule of requirement published on KPTEVTA Website and having specialty /experience as described in BSD.
- 4) Sale tax, Income Tax and any other taxes / Duties Levied against the item shall be deducted at prescribed rate as per Government Policy.
- 5) All bidders must submit the relevant details of technical & financial proposals in separate Envelopes and also to provide documents in soft copies on USB DRIVE, duly labelled by a permanent marker with the name of bidder/supplier.
- 6) The firm may not be blacklisted/debarred temporarily or permanently by any Government/Autonomous/Semi-Autonomous/authority. If at any stage of the procurement process a firm is found blacklisted/debarred temporarily or permanently and information is not shared by the firm/bidder with KP-TEVTA then, KP-TEVTA shall have the right to forfeit 2% bid security or 10% Performance Guarantee in favor of KP-TEVTA. The statement of non-blacklisting shall be submitted along the Technical bids through an affidavit on official stamp paper of worth Rs.100/- of Government of Pakistan.
- 7) The supplier must be registered with the Sales Tax and Income Tax Department and other relevant Authorities depending on the procurement. Photocopy of valid registration shall be attached with the bid documents.
- 8) The Supplier shall write in bold & legible letters "Name of the Project" on Top-Left and Package Name on Bottom Right of the envelop, otherwise tender will not be entertained.
- 9) **This Tender Notice, List of Equipment along with minimum Specifications and Bid Solicitation documents can be downloaded from the KP-TEVTA, official website www.kptevta.gov.pk.**
- 10) The Bid Processing fee @ Rs. 1000/- (Non-Refundable) through Pay order in the name of Managing Director KP-TEVTA Peshawar and will be submitted along with the application with bid separately on Firm's letter head for the projects in which the bidder is applying. Otherwise bid will be considered non-responsive.
- 11) Two (2%) Percent bid security of the bid cost in shape of Call Deposit Receipt (CDR) in favour of Managing Director KP-TEVTA must be sealed in financial proposal. However, the technical Proposal shall have affidavit stating that 2% bid security is enclosed in the financial proposal without stating the figures. Otherwise bid will be considered non-responsive. **Pay Orders will not be accepted.**
- 12) The rates shall be on FOR basis and format of BSD form 06 (price schedule) shall be strictly followed; otherwise financial bid will be non-responsive considered.
- 13) The successful Bidder will deposit 10% as performance Guarantee with letter of Acceptance and Contract Agreement before the issuance of purchase order (through Call Deposit Receipt (CDR)). 10% Performance Guarantee will be released after successful supply or Completion of warranty period.
- 14) Bid validity period will be applicable for fiscal year 2021-22. However, timeline will be strictly followed as per KPPRA Rules.
- 15) The supplier will submit the tender documents properly **Computer Typed/Page Numbered** along with terms and condition issued by the KP-TEVTA dully signed by the authorized personnel with company seal. Soft Copy of Technical Bid with complete technical specifications of the quoted items shall be provided in a USB Drive; otherwise the bid will not be accepted.
- 16) The bidder will be responsible for standard warranty given by the manufacturer where applicable.
- 17) The Competent Authority reserves the right to increase or decrease the quantity of items as per availability of budget as well as on the recommendation of the procurement committee.
- 18) The Competent Authority reserves the right to reject any or all the bids as per KPPRA rules with cogent reason.
- 19) Any other condition included in KPPRA rules, 2014 besides the above shall also be applied on the bidders.
