- d. Valid Enlistment Certificate with C&W Department for the Current Financial year.
- Firm Having Experience in Building Particularly in Educational Institutes related works and having the PEC code for high rise building BC03 and other relevant codes for civil and electrical works.
- 3. As per direction of notification honorable Additional Chief Secretary KP vides his notification No.Chief/INF/P&D/003-02/2022/01. All the interested bidders shall deposit their call deposit Receipt (CDR) in the name of Procuring Entity five days prior to the closing date of bid submission. The Procuring Entity shall ensure that the bids of only those

bidders be opened whose Security deposit has been Certified to their official account before opening of bids, in case, no security deposit is certified, the bid shall be considered nonresponsive and shall summarily be rejected

- 4. The contractors quoting their bids up to a limit of 15% below Engineer estimate shall submit bid security to extent of 2% of Engineer Estimate only.
- 5. The contractors quoting their bids more than 15% below on Engineer's Estimate shall submit along with their bids an additional security to the extent of their bid/rates more than 15% below on engineer estimate in the form of percentage.
- 6. In case the bidder quotes more than 15% below the Engineer Estimate and the bid is not accompanied by the additional security then the bid shall be considered as non-responsive and the  $2^{nd}$  lowest bidder and so on will be considered accordingly. (All others terms should be apply as per KPPRA notification No.SRO(13/Vol:1-21/2021-22 Dated Sep 15, 2021).
- 7. Each bidder shall submit only one bid either by himself or as a Joint Venture. A bidder who submits or participate in a more than one bid (other than alternative pursuant to clause IB.16) will be disqualified
- The bidder are required to quote their rates above below on BOQ MRS-2021 System as well as NSI Items.
- 9. Any bidder who provide false/fake information shall stand disqualified and will be debarred.
- 10. Bids validity period is ninety 90 days.
- 11. Successful bidder should sign the agreement with the Department within 28 days after issuance of LOA.
- 12. Performance Bank Guarantee from Scheduled Bank will be acceptable only as per KPPRA Rules
- 13. The Procuring Entity may reject all bids at any time prior to the acceptance of bid. The procuring Entity upon request communicate to any contractor who submitted a bid, the ground of rejection of bids.
- 14. All bidders are required to register their Firms with Khyber Pakhtunkhwa Revenue Authority (KPPRA) per Notification Para-37(A)
- 15. Bid Security of the 1st, 2nd and 3rd lowest evaluated bidders will be retained by the Department till approval of bids.
- 16. Incomplete/Conditional Documents shall not be accepted
- 17. Any other information required can be obtained from the office of the undersigned.
