TERMS & CONDITIONS (PROC: 22-7-01)

- 1) Bids are invited from suppliers under **Single Stage, Two Envelop** procedure. Bids completed in all respect should reach to the Office of Director Procurement, Khyber Pakhtunkhwa Technical Education and Vocational Training Authority through registered mail or Courier Services on or before above mentioned dates and time. The bids will be opened on the same day by the Procurement committee in the presence of bidders/Representatives who want to attend. Incomplete & Bid submitted after due date & time shall not be entertained.
- 2) The Items/Equipment must have Minimum Specification acceptable to the Technical Committee of KP-TEVTA; however the higher specification may be accepted if within the financial limit.
- 3) The bidder should apply for entire package/project and incomplete bid for the package/project will be considered non responsive.
- 4) Bidder can bid for items as per Schedule of requirement published on KPTEVTA Website and having specialty /experience as described in BSD.
- 5) Sale tax, Income Tax and any other taxes / Duties Levied against the item shall be deducted at prescribed rate as per Government Policy.
- 6) All bidders must submit the relevant details of bid/proposals duly labelled by a permanent marker with the name of bidder and also to provide documents in soft copies (MS WORD format) on USB drive
- 7) The supplier must be registered with the Sales Tax and Income Tax Department. Valid registration shall be attached with the bid documents.
- 8) The Supplier shall write in bold & legible letters "Name of the Project" on the envelope.
- 9) ***This Tender Notice, Schedule of Requirement (list of Equipment along with Specifications) and Bid Solicitation documents can be downloaded from the KP-TEVTA, official website www.kptevta.gov.pk.***
- 10) The Bid Processing fee @ Rs. 3000/- (Non-Refundable) through bank cheque payable in Bank of Khyber A/C # 06566, Civil Secretariat Peshawar and will be submitted along with bid separately on Firm's letter head. Otherwise bid will be considered non-responsive.
- 11) Bidders shall enclose 2% as Bid Security in the bid's envelop in the form of Call Deposit Receipt (CDR). Pay Orders will not be accepted. It will be released after successful submission of 10% Performance Guaranty through CDR or Bank Guarantee on a Local stamp paper. Performance Guarantee will be released after successful Completion of warranty period.
- 12) The rates shall be on FOR basis and store must be delivered to the specified consignee's end as mentioned in Purchase Order (PO) while PO is the integral part of procurement. In case of failure of supply, the performance Guarantee shall be forfeited in favour of KP-TEVTA.
- 13) Bid validity period will be applicable for fiscal year 2020-21 and can be extended by mutual consent in case of force majeure or if required.
- 14) The supplier will submit the tender documents properly Computer Typed and each page shall be endorsed and numbered along with terms and condition issued by the KP-TEVTA dully signed by the authorized personnel with company seal; otherwise the bid will not be accepted.
- 15) The bidder will be responsible for standard local warranty given by the manufacturer where applicable.
- 16) The Competent Authority reserves the right to increase or decrease the quantity of items as per availability of budget.
- 17) The Competent Authority reserves the right to reject any or all the bids as per KPPRA rules with cogent reason.
- 18) Any other condition included in KPPRA rules 2014, besides the above shall also be applied on the bidders.
