TERMS & CONDITIONS

- Bids are invited from Authorized suppliers/Manufacturers under **Single Stage, Two Envelop** procedure. Bids completed in all respect should reach to the Office of Director Procurement, Khyber Pakhtunkhwa Technical Education and Vocational Training Authority through registered mail or Courier Services on or before above mentioned dates and time. The bids will be opened on the same day by the Procurement committee in the presence of bidders/Representatives who want to attend. Incomplete & Bid submitted after due date & time shall not be entertained.
- The Items/Equipment must have Minimum Specification acceptable to the Technical Committee of KP-TEVTA; however the higher specification and branded items may be acceptable.
- The bidder should apply for entire package/project and incomplete bid for the package/project will be considered non responsive and will be on the disposal of the Procurement committee to decide.
- Bidder can bid for package as per Schedule of requirement published on KPTEVTA Website and having specialty /experience of at least 05 years in the relevant Trade/Technology.
- Sale tax, Income Tax and any other taxes / Duties Levied against the package shall be deducted at prescribed rate as per Government Policy.
- All bidders must submit the relevant details of bid/proposals duly labelled by a permanent marker with the name of bidder and also to provide documents in soft copies (MS WORD format) on USB drive otherwise bid will be rejected.
- Valid Sales & Income Tax registration shall be attached with the bid documents.
- The Supplier shall write in bold & legible letters "Name of the Project" and "Package" on every envelope.
- The supplier will submit the tender documents properly Computer Typed and each page shall be endorsed and numbered along with terms and condition issued by the KP-TEVTA duly signed by the authorized personnel with company seal; otherwise the bid will not be accepted.
- This Tender Notice, Schedule of Requirement (list of Equipment along with Specifications) and Bid Solicitation documents can be downloaded from the KP-TEVTA, official website www.kptevta.gov.pk.**
- The Bid Processing fee @ Rs. 3500/- (Non-Refundable) through pay order or CDR in Bank of Khyber A/C # 06566, Civil Secretariat Peshawar and will be submitted along with bid separately on Firm's letter head. Otherwise bid will be considered non-responsive.
- Bidders shall enclose 2% of the Bid Value as Bid Security in the bid's envelop in the form of Call Deposit Receipt (CDR). Pay Orders will not be accepted as bid security. It will be released after successful submission of 10% Performance Guaranty through CDR. Performance Guarantee will be released after successful Completion of the quoted/qualified warranty period.
- The rates shall be on FOR basis and stores must be delivered to the specified location as mentioned in Purchase Order (PO).
- Bid validity period will be applicable for fiscal year 2022-23 and can be extended by mutual consent in case of force majeure or if required.
- The bidder will be responsible for standard local warranty given by the manufacturer where applicable.
- The Competent Authority reserves the right to increase or decrease the quantity of items as per availability of budget mentioned in the Bid Data Sheet of the BSD.
- The Competent Authority reserves the right to reject any or all the bids as per KPRA rules with cogent reason.
- Any other condition included in KPRA rules 2014, besides the above shall also be applied on the bidders.
