In compliance to the Khyber Pakhtunkhwa Technical & Vocational Training Authority (KP-TEVTA) Peshawar, Government Technical & Vocational Centre for Boys Ghazi intends to purchase Training Material/Raw Material for different workshops of GTVC (B) Ghazi District Haripur Khyber Pakhutunkhwa as estimated cost of Rs.600000/-(Six Hundred Thousand Rupees only) in which amounting to Rs.300000/-(Three Hundred Thousand Rupees Only) is release and remaining amount will be paid after the release of budget to GTVC Ghazi.

TERM AND CONDITION

- Financial bids are invited from the firm through registered Dak under a single stage one envelop system
 and shall reach to the office of Principal up-to 13-04-2023 at 10.00 A.M and shall be opened on the
 same day by the purchase committee constituted by Principal GTVC (B) Ghazi Haripur in presence of
 supplier/authorized agents at 11.00 AM, who wants to attend. Bids received after 10.00 AM on 13-042023 shall not be entertained.
- The items/material must have minimum specification acceptable to the Technical/purchase committee
 of the GTVC (B) Ghazi Haripur, however higher specification may be accepted if come within the
 financial limit.
- 3. The supplier /bidder can bid for items as per schedule of requirement published on KP-TEVTA web site and having specialty/expenses.
- 4. The firm/supplier must be registered with the KPPRA, Sale tax and income tax department (Registered on active tax payer list of FBR and NTN & GST Number) photo copy of valid registration shall be attached with the bid documents
- Sale Tax, income tax, any other taxes/duties levied against the item shall be deducted at prescribed rate as per Government policy.
- 6. Two percent as bid Security (Earnest money) of the quoted value in shape of call deposit in favour of the Principal GTVC (B) Ghazi Haripur must be submitted with the bid document. The bid security will be released to the unsuccessful bidders after the award of contract to successful bidder and 10% performance guarantee CDR or Bank Guarantee on local stamp paper, performance will be released after successful completion of supply. In case of failure the performance guarantee will be forfeited in favor Principal GTVC (B) Ghazi Haripur.
- Detailed term and condition and bids documents can be obtained from office of the Principal GTVC
 (B) Ghazi Haripur on any working day or can be downloaded from the KP-TEVTA Official website www.kptevta.gov.pk.
- 8. Bidding shall be done on items rate system. Bidder should fill their own rate amount in the blank column against each item. Any bid based on ambiguous rate in the item rate/rate tender shall be termed as defective, non-responsive and shall be rejected.
- Any item not reflected in the tender and required shall be paid in accordance with schedule rate analysis as per recommendation and prior approval of the competent authority.
- 10. The call deposit of the bidders shall be retained by this office until signing of contractor agreement by the successful bidder.
- 11. The contractor shall quote their rate both in figure as well as in words, over writing is not accepted.
- 12. Technical evaluation of contractor or from and all precruitment shall be carried out as per KPPRA rules.
- 13. Conditional tender will not be accepted.
- 14. Supply must be completed up to date mentioned in the supply order.
- 15. The inspection committee of this Training Centre will carry out the inspection of all items before payment to the supplier.
- 16. Any other rules/law applied by the KP-TEVTA/KPPRA Govt: of KP shall be applied in true letter & spirit.
- 17. The competent authority reserved the rights to increase or decrease the quantity of items on the recommendation of purchase committee or reject any or all the bids as per KPPRA rules with cogent reasons.
