1. INSTRUCTIONS:

1.1 Introduction

1.1.1 Scope

Khyber Pakhtunkhwa Technical Education and Vocational Authority (KP-TEVTA) is an autonomous organization mandated to impart quality training enabling youth of the Province to improve socio-economic livelihood and employability.

KP-TEVTA intends to invite Expression of Interest (EOI) from registered Industrial Units/Firms/SMEs and Cottage Industries for Job Market Integration/Induction (OJT) to all TEVT sectors pass-outs in 2023 and onward in their respective trades/occupations for enhancement of their skill capabilities enabling them to get employment/self-employment at National and International level. Duration of the Job Market Integration/Induction (OJT) will be 06 months and the internees will be entitled to monthly remuneration @ Rs. 15,000/per month by KP-TEVTA out of project fund and @ Rs. 5,000/- per month will be paid by the concerned Industry unit/Firm/SMEs/Cottage Industries subject to attaining of 75% monthly attendance.

1.1.2 Terms and Conditions

Following are the Terms and Conditions for Job Market Integration/Induction (OJT); **Service Providers:**

- i) Registered Industrial Units/Firms/SMEs and Cottage Industries will participate in the process having at least 10 employees.
- ii) Evidence of business / enterprise and estimated annual turnout
- iii) Workshop / practical learning facility with competent HR
- iv) Conducive work environment
- v) Outsourcing/subletting of the Job Market Integration/Induction (OJT) will not be allowed
- vi) KP-TEVTA team shall be allowed for regular monitoring of the enrolled trainees
- vii) The Management of concerned entities shall regularly monitor the training program and furnish monthly attendance of each trainee
- viii) Rs. 5,000/- per month per trainee will be paid by the concerned Industry unit/Firm/SMEs/Cottage Industries subject to attaining of 75% monthly attendance.
- ix) The Management shall regularly assess the trainees
- x) Make necessary arrangements for award of certificates

KP-TEVTA:

- i) Monitor the training program
- ii) Arrange monthly stipend based on the attendance (75% per month)
- iii) KP-TEVTA teams shall ensure regular assessment of practical training of the trainees
- iv) KP-TEVTA and Management of the concerned entities shall ensure
