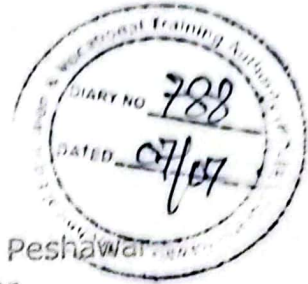

Meeting was held under the chairmanship Mr. Shahab Ali Shah, Worthy Chief Secretary, Khyber Pakhtunkhwa at 2:00 PM on 19<sup>th</sup> June 2025 in the Board Room, Civil Secretariat, Peshawar. The meeting was attended by Team Lead NSTOP, Team Lead UNICEF, and the Representative WHO.

2. After recitation of verses from the Holy Quran, the worthy Chief Secretary welcomed all participants of the meeting. Mr. Shafiullah Khan, Additional Secretary, Health /Provincial EOC Coordinator, gave a detailed presentation on the following points:

- Epidemiological and Programmatic Risk Classification
- ES Results and Polio Cases 2024 - 2025
- Assessment of Virus Circulation Peshawar
- Community Transmission Peshawar 2022 - 2025
- What the Case Data tells us
- Summary of Epidemiological Assessment
- South KP: The Most Challenging Region for Polio Eradication
- Key Operational Issues in South KP

#### Decisions:

1. Establishment of Permanent Transit Teams (PTTs) at Azad Mandi and Nurar at Bannu – WHO Team Lead KP.
2. Action against UC Staff who boycotted and protested against the monitoring of the UC by the Immunization Officer, WHO – DC Karak.
3. LQAS to be planned and conducted in South Waziristan Upper, South Waziristan Lower, Bannu, DI Khan, and Kurram, including their COMVI UCs – Coordinator EOC & WHO Team Lead KP.
4. Kurram and North Waziristan to submit their plans by the closing of business for Leftover Area coverage – DCs Kurram and North Waziristan.
5. Social intelligence to be gathered by Deputy Commissioners during and post campaign on fake finger marking – All Deputy Commissioners Khyber Pakhtunkhwa.
6. Form B issuance to be made subject to mandatory provision of routine immunization completion – All Deputy Commissioners, Khyber Pakhtunkhwa / NADRA Chief, Khyber Pakhtunkhwa.
7. The Annual Performance Evaluation Reports of those Civil Servants having under 5-year-old children, including semi-autonomous and autonomous, would be linked to their Polio Vaccination status – All Secretaries to the Government of Khyber Pakhtunkhwa.
8. Note on linking services of BISP to Polio Vaccination status may be initiated – Coordinator EOC Khyber Pakhtunkhwa.
9. Two meetings may be arranged with DCs and DHOs in the next week, focusing on challenges and recommendations as follows:
  - a. Meeting 1: Districts North Waziristan, Bannu, Kurram, Karak, and Khyber.
  - b. Meeting 2: Districts Abbottabad, Charsadda, Dir Lower, and Mardan
