

TERMS & CONDITIONS

- E-Bids are invited from Authorized suppliers/Manufacturers under <u>Single Stage, Two Envelop</u> procedure. Bids completed in all respect should submit online through KP-PPRA EPADS system on or before above mentioned dates and time. The e-bids will be opened on the same day by the Procurement committee in the presence of bidders/Representatives who want to attend. Incomplete & Bid submitted after due date & time shall not be entertained.
- 2) The Procurement shall be conducted through EPADS (E-PAK Acquisition Disposal System). Manual bids shall not be accepted.
- 3) E-Biding documents containing detailed terms & conditions, Schedule of Requirement (list of Equipment along with Specifications) and Bid Solicitation documents are available for the registered bidders on EPADS at https://kp.eprocure.gov.pk. Bidders shall submit e-bids only through EPADS.
- 4) The Items/Equipment must have Minimum Specification acceptable to the Technical Committee of KP-TEVTA; however, the higher specification and branded items may be acceptable.
- 5) Sale tax, Income Tax and any other taxes / Duties Levied against the package shall be deducted at prescribed rate as per Government Policy.
- 6) The Bid Processing fee @ Rs. 4,000/- (Non-Refundable) through pay order or CDR in Bank of Khyber (A/C Title MD KP-TEVTA Fund) A/C # 3004607348, KTH Branch, Peshawar and will be submitted separately on Firm's letter head. Otherwise bid will be considered non-responsive.
- 7) Bidders shall enclose 2% of the Bid Value as Bid Security in the form of Call Deposit Receipt (CDR). Pay Orders will not be accepted as bid security.
- 8) Successful bidders shall submit 10% Performance Guaranty through CDR. Performance Guarantee will be released after successful Completion of the quoted/qualified warranty period.
- The rates shall be on FOR basis and stores must be delivered to the specified location as mentioned in Purchase Order (PO).
- 10) Bid validity period will be applicable for fiscal year 2025-26 and can be extended by mutual consent in case of force majeure or if required.
- 11) The bidder will be responsible for standard local warranty given by the manufacturer where applicable.
- 12) The Competent Authority reserves the right to increase or decrease the quantity of items as per availability of budget mentioned in the Bid Data Sheet of the BSD.
- 13) The Competent Authority reserves the right to reject any or all the bids as per KPPRA rules with cogent reason.
- 14) Any other condition(s) included in KPPRA rules 2014, besides the above shall also be applied on the bidders.
